1.4.3 Continue to engage the Medical-Legal and Managed Care provider partnerships to provide legal services for families and youth who have lost insurance, SSI or who have other legal concerns. Provide one to two clinic sessions per month with a representative from the Medical-Legal partnership to provide onsite assistance in the JaxHATS clinic and advice to families and patients. 1.4.4 Establish a working group for dental care for YYASHCNs in Jacksonville. This group will work towards the expansion of dental services in Jacksonville.		
1.4.5 Compile a list of mental and behavioral health providers in NEFL and collaborate with these agencies to develop models of care that will provide increased access and services to YYASHCNs in NEFL.		
1.4.6 Develop a model for tracking outcomes (ie: ED visits, hospital admissions, education/vocation outcomes, loss of insurance) of patients while engaged in healthcare transition services. 1.4.7 Continue to promote the development and expansion of our newly initiated JaxHATS/YYASHCNs youth council. This group will provide this coalition with critical feedback related to the needs of YYASHCNs and will guide us in developing coalition objectives and priorities. Our youth council will also be involved in community outreach and social planning for YYASHCNs in NEFL.		
1.4.8. Expand the JaxHATS program into a comprehensive system of care (as opposed to a clinical program) that provides transition services to all emerging adults in the community, with a particular focus on special populations such as those with complex medical or developmental conditions, young adults aging out of foster care, in the juvenile justice system, girls enrolled in the PACE program, LGBTQ youth, homeless youth and victims of human trafficking.
