<p>Ms. DeBriere shared that the Medical Legal Partnership provide legal services children, youth and young adults/and their families of the following organizations: Wolfson Children’s Hospital, UF Health Bower Lyman Complex Care Clinic, Nemours Children’s Outpatient Clinic and other ID/DD community organizations. The JALAA/MLP provides legal services for pro bono to eligible patients that request legal guidance with income support, housing, utilities, education, and legal immigration status, personal and family issues. Staff refer potential patients from one the collaborating health care organizations for coordination of eligibility services/intake with Ms. DeBriere. During the presentation, Ms. DeBriere</p>

Mrs. Prewitt was the past chair and currently committee member for the Family Care Council Area 4 for the Agency of Persons with Disabilities (APD). She is currently a council member for the Jacksonville Mayor's Disability Council. Mrs. Prewitt also serves as Board Member on the North Florida School of Special Education Board, Management Team Member for the Special Olympics and Past Chair/Council Member for Horse Sense &amp; Sensitivity.</p> <p>Karen talked about the beneficial services, support and opportunities for the ID/DD community offered by the Family Care Council (Area 4) and the Jacksonville Mayor's Disability Council. Karen also familiarized the audience with navigational demonstration of each the website. She highlighted APD's website directory that is structured around the needs of ID/DD population. Karen also expounded on the structure/roles, functions and service offered of each council. She also shared that both FCC and JMDC have openings available for interested persons that want to apply for council membership.</p> </li> <li> <p><b>Edward Monagan</b>, Adult Services Manager at Hope Haven a nonprofit provider that specializes in services for children and adults with special needs and their families. Mr. Monagan brings 20 years of experience of working with children and adults with disabilities from managing group homes, Intermediate Care Facilities to investigating child abuse cases to empowering single mothers of children with disabilities.
